### -2-Part I – General Information

- Last date and time for depositing the bids. The last date for depositing bids is 29 January 2022
- 2. <u>Eligibility Criteria and Forwarding of Bids.</u> The bidder must be OEM (Original Equipment Manufacturer) and should have preferably installed at least one similar project in any school/Institution. If due to any exigency, the due date for opening of the Bids is declared a closed holiday, the Bids will be opened on the next working day at the same time or on any other day/time, as intimated by the School.
- 5. Location of Tender Box. Patiala Gate, Yol Cantt. Only those bids that are found in the tender box will be opened. Bids dropped in the wrong Tender Box will be rendered invalid. Bids may also be fwd through registered post. Such bids should reach school office well in time. Bids reaching late due to any reason (including postal delay) will not be accepted.
- 6. <u>Cost of Tender</u>. Crossed demand draft of Rs. 100/- (Rupees One Hundred only) in favour APS Yol Cantt, payable at SBI Yol Cantt will be deposited as tender fee (non-refundable). DD should be valid for minimum six months period. Tender fee is NOT exempted for any firm. The Demand draft will be deposited along with the bids.
- 7. Opening of the Bids. The physical verification of tender bids will be done by a Procurement Committee at Army Public School, Yol Cantt. The Bidders may depute their representatives, duly authorized in writing, to attend the opening of bids on the due date and time. However, the same is not mandatory. This event will not be postponed due to non-presence of your representative.

Only techno commercial bid (single bid) will be required from Bid System. tenderers.

- Bid should be forwarded by Bidders under their original memo/ letter pad inter alia furnishing details of GST Regn No, Bank details and complete postal and e-mail address of their office.
- A prospective bidder who Clarification Regarding Contents of the RFP. requires clarification regarding the contents of the bidding documents shall notify to the Buyer in writing about the clarifications sought not later than 25 Jan 2022. Copies of the query and clarification by the purchaser will be sent to all prospective bidders who have received the bidding documents.

#### Modification and Withdrawal of Bids. 11.

- Any Tenderer, who proposes alterations to any of the condition, specifications laid down in the Tender documents or any new condition, whatsoever, is liable to be rejected. No bid shall be modified after the deadline for submission of bids.
- If a bidder desires to withdraw before bid submission closing date/time, he may do so but cost of the tender will not be refunded.
- No bid may be withdrawn in the interval between the deadline for submission of bids and expiry of the period of the specified bid validity.
- During evaluation and Clarification Regarding Contents of the Bids. comparison of bids, the Buyer may, at its discretion, ask the bidder for clarification of his bid. The request for clarification will be given in writing and no change in prices or substance of the bid will be sought, offered or permitted. No post-bid clarification on the initiative of the bidder will be entertained. Should there be any requirement the buyer may ask the vendor to give a presentation and demonstration to clarify any matter on no cost no commitment basis.
- Canvassing by the Bidder in any form, unsolicited letter and Rejection of Bids. post-tender correction may invoke summary rejection. Conditional tenders will be rejected. This being a turnkey project, Bidders will bid for all items. Piecemeal/partial bids will be rejected.
- The Bids should remain valid till 45 days from the last date of Validity of Bids. 14. submission of the Bids.
- Earnest Money Deposit. Bidders are required to submit Earnest Money Deposit (EMD) for amount of Rs 10,000/- (Rupees five housand only) or certificate of exemption, if any along with their bids. Further details are furnished below:-

- The EMD may be submitted in the form of a Bank draft/BG from any of the public sector banks or a private sector bank authorised to conduct business with government. The same is to be drawn in favour of Army Public School Yol Cantt, payable at Yol.
- The EMD is to remain valid for a period of forty-five days beyond the final bid validity period. EMD of the unsuccessful bidders will be returned to them, without any interest whatsoever, at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The Bid Security of the successful bidder would be returned, without any interest whatsoever, after the receipt of Bank guarantee from them as called for in the contract.
- Forfeiture. The EMD will be forfeited if the bidder withdraws or amends impairs or derogates from the tender in any respect within the validity period of their tender. If the successful vendor/firm fails to furnish the required performance security then the EMD furnished will be forfeited.
- Payment. 80% payment will be made on completion of the project and rest 20% payment will be made after one month ie after successful working of the system for one month and satisfactory performance certificate by the user.
- Performance Bank Guarantee (PBG). The Bidder will be required to furnish a Performance Guarantee by way of Bank Guarantee through a public sector bank or a private sector bank authorised to conduct government business (ICICI Bank Ltd, Axis Bank Ltd or HDFC Bank Ltd) for amount of 10% of the total cost of the project within 20 days of receipt of the confirmed order. Performance Bank Guarantee will be kept with the Principal, Army Public School, Yol Cantt, Himachal Pradesh, Pin 176052 and should be valid upto 12 months from the date of supply order.

### Pre-Requisite for OEM (Original Equipment Manufacturer): 17.

- a. OEM should have a registered office in India to provide after Sales service support in India. Copy of Certificate of Incorporation must be submitted.
- b. OEM must be complied with BIS and ISI standards
